FROM A DISTINGUISHED INSIDER: BUILDING UTAH'S THIRD BRANCH OF GOVERNMENT



We are pleased to announce that the Honorable Christine Meaders **Durham** will be the speaker at our **Wednesday**, **February 13 luncheon**. Justice Durham served on the Utah Supreme Court from 1982 to 2017 and as Chief Justice and chair of the Utah Judicial Council from 2002 to 2012. Before joining the Supreme Court, she was a practicing attorney in Utah and served on the state trial court. A native of California, Christine's family moved to Paris when she was a teenager, and she finished her schooling there. Returning to the U.S., Durham earned her A.B. with honors at Wellesley College and her J.D. at Duke University.

Justice Durham is an emeritus member of Duke's board of trustees, a past-president of the Conference of Chief Justices of the United States, and a former chair of the American Bar Association's Council on Legal Education and Admissions to the Bar. She was a founder of the Leadership Institute in Judicial Education and helped create and lead the Utah Coalition for Civic Character and Service Education. For many years she taught state constitutional law as an adjunct professor in the University of Utah's S.J. Quinney College of Law. In 2007 she received the William H. Rehnquist Award for Judicial Excellence. She now co-chairs Utah's Coordinating Committee on Access to Justice and the Utah Center for Legal Inclusion. She is also a member of the Board of Trustees of University of the People, an accredited tuition-free online institution. Pediatrician George Durham has been married to Christine since the late-1960s. Together they reared five children.

We look forward to a stimulating presentation and lively conversation with Justice Durham on February 13th!


